# Stalin Criticizes PM Modi for Skipping Katchatheevu, Fishermen Talks During Lanka Visit

New Delhi: Tamil Nadu Chief Minister MK Stalin today accused Prime Minister Narendra Modi and the Union government of neglecting the longstanding demands of the state's fishermen. He stated that despite the Prime Minister's recent visit to Ŝri Lanka, there has been no concrete action to address the repeated arrests of Indian fishermen by the Sri Lankan Navy or to retrieve the Katchatheevu island.

In a statement made in the Tamil Nadu Assembly, Stalin said, "This only shows that Tamil Nadu's demand for retrieving Katchatheevu has been ignored. It does not appear that Prime Minister Narendra Modi, who went to Sri Lanka, raised the fishermen's release, too. This is regrettable and disappointing."
He added that the BJP-led Union

government has let down the fishermen, but assured that the DMK government will not fail to protect their livelihood.

Stalin reiterated that the state government stands firmly with the fishermen and is committed to their welfare, regardless of the Centre's response. "No matter how the Union government behaves, we will not fail to protect our fishermen's livelihood. The DMK government will stand with the

fishermen," he declared.
Just days after Modi's visit to Sri Lanka the Tamil Nadu government passed a resolution in the Assembly on April 2, urging the Centre to find a permanent solution to prevent the continuous arrests of Tamil Nadu fishermen by the Sri



Lankan Navy. The resolution called for the retrieval of Katchatheevu island, the release of fishermen from Sri Lankan prisons, and the return of their seized

The resolution also pressed the Prime Minister to raise these issues directly with the Sri Lankan government during his visit, as a demonstration of goodwill and to safeguard the traditional fishing rights of Tamil Nadu fishermen.

Despite these appeals, only 14 Indian fishermen were released by Sri Lanka the day after Modi met Sri Lankan President Anura Kumara Dissanayake. While the Union government claimed that Modi advocated for resolving the fishermen issue with a humane approach, Stalin criticised the lack of clear action or mention of Katchatheevu and the remaining imprisoned fishermen.

Reaffirming his government's commitment, Stalin announced a range of welfare measures for the fishing community, including the establishment of a fishing harbour at Thangachimadam in Rameswaram, a region heavily affected by the ongoing dispute.

# 'Tarrifying': Congress Targets PM Modi as Trump Tariffs Send Shockwaves Through Indian Markets

New Delhi : The Congress today intensified its attack on Prime Minister Narendra Modi as stock markets in India crashed following US President Donald Trump's tariff announcements last week.

Comparing PM Modi to his US counterpart, Congress said that both leaders are experts in delivering "selfinflicted wounds" to their countries as a result of which the markets are responding in a "tariffying" manner.
"It is no wonder that Mr. Modi and Mr.

Trump describe themselves as good friends. Both are experts in giving their economies self-inflicted wounds," Congress MP Jairam Ramesh said on his official X handle on Monday, soon after both Sensex and NSE Nifty sank by nearly 4,000 points and 1,200 points respectively.

The crash wiped out nearly Rs 19 lakh crore within a few minutes of the market opening as Sensex plunged to a l 0-month low

"Nov 8, 2016 was demonetisation. April 2, 2025 was the bizarre reciprocal tariffs. Markets are reacting predictably in a tariffying manner," Ramesh added. Last week, Leader of Opposition in Lok Sabha, Rahul Gandhi, speaking on

the floor during the Zero Hour, warned the Narendra Modi government that tariffs would "completely devastate" the Indian industry.

Demanding answers from government on how they intend to protect the domestic economy amid Trump's tariff announcements, Rahul Gandhi said, "Somebody once asked Indira Gandhi ji - 'In the matter of foreign policy you lean left or you lean right,' and Indira Gandhi ji answered, 'I don't lean left or right, I stand straight.' Putting the spotlight on the PM Modi-Trump bonhomie, Congress President Mallikarjun Kharge said in the Rajya Sabha last week, "America is a businessman and our customer got trapped.'

Congress MP Manish Tewari followed suit, calling the additional tariffs a "complete failure" of the Modi government in negotiating with the Trump administration.

# Court Slams UP for Converting Civil Cases into Criminal, Calls it Breakdown of Rule of Law

New Delhi: The Supreme Court today blasted the Uttar Pradesh Police for routinely converting civil disputes into criminal cases, calling it "absurd" and a "complete breakdown" of the rule of law. While hearing a cheating case, the top court said a case of not returning money doesn't constitute a criminal offence.

"This is something strange which is happening day in and day out in UP. A case of merely giving money and not returning that money is not a criminal offence. This is absolutely no case. This is a breakdown of the rule of law," the Supreme Court said.

This is the second time in four months that the Supreme Court has expressed concern over the growing number of civil disputes turning into criminal cases in Úttar Pradesh.

The Supreme Court was considering a plea where allegations of cheating have been made against an accused. The police filed a criminal case against the accused.

While a civil case pertains to disputes between individuals or organisations and involves seeking compensation or remedy, a criminal case is filed for violating the law and involves varying degrees of punishment



The top court also pulled up the investigating officer in the case and

warned of proceedings.
"This is absurdity... I will ask the investigating officer to stand in the witness box and record his presummoning evidence. I will haul up and begin proceedings against the IO," the top court said while staying trial

court proceedings in the case.

In December, the top court asked the UP Police chief to curb the routine conversion of civil disputes into criminal cases and stop the harassment of civilians. The court warned that if the practice did not cease, it would pass orders that the police chief would "remember his whole life".

The strong remarks came while the court was hearing the anticipatory bail plea of a person against whom criminal cases were lodged over various land

# Chaos Erupts in Assembly as MLAs Tear Copies of Waqf Act, Slogans Fill the Air

Srinagar: The Jammu and Kashmir Assembly today witnessed a huge uproar over the newly enacted Waqf law, as the Speaker turned down the adjournment motion - meant to suspend other proceedings in the House to discuss a matter of public importance - moved by the ruling party National Conference (NC)

legislators. The Assembly resumed after being adjourned for 15 minutes, as the NC MLAs chanted "Modi Sarkar hai, hai" while storming into the well of the House. Dismissing the adjournment motion, Speaker Abdul Rahim Rather, citing Rules 56 and 58 (7), said that "no matter which is sub-judice can be brought up for adjournment." "Since this issue is in the Supreme Court and I have got a copy of it, the rule clearly says that we cannot discuss it through an adjournment motion," he added.

After the Speaker's refusal to take up the matter for urgent discussion, massive protests erupted among the NC legislators. As protests erupted in the assembly, NC MLAs, Hilal Lone and Salman Sagar, tore copies of the Waqf Act. The situation further worsened when NC MLA Abdul Majeed Larmi tore his jacket on the floor of the House in protest

Revealing the reason why Larmi resorted to such an extreme measure, the NC MLA told: "The Modi government must withdraw Waqf law just like farm laws were rolled back. We won't allow



roceedings of the assembly to take place till this law is withdrawn. Our religious sentiments have been hurt. That's why I tore my jacket.

Denouncing the NC's move, Leader of the Opposition in the Assembly, Sunil Sharma, called the ruling party's demand "highly unconstitutional."
"Parliament has passed the bill, the

President has given assent, and it is now law," said Sharma. Reiterating the Speaker's objection to the adjournment motion, he said that "when the matter is with the judiciary, this Assembly has no authority to debate or discuss it."

Sharma further stated that if a sub-judice matter is brought up for discussion in the assembly, then it would amount to violating constitutional norms.

Meanwhile, PDP chief Mehbooba Mufti

called the Speaker's decision to reject the adjournment motion "profoundly disappointing." Expressing surprise, she said that despite being in majority, the NC-Congress alliance "completely yielded to the BJP's anti-Muslim agenda, cynically attempting to appease both side

# Millions in India Unaware of Chronic Illnesses. Reveals Apollo Health Report

on screenings of 53,000 individuals, 33% of men and 10% of women were identified as high-risk of sleep apnea.

Risk levels rise sharply with age, affecting 68% of men and 22% of women over 55.

Despite its high prevalence, OSA remains underdiagnosed, often mistaken for general fatigue or stress. Doctors are calling for routine sleep risk assessments in metabolic screenings, stronger public awareness about OSA symptoms, and workplace wellness programs that address sleep hygiene as a core pillar of preventive care.

Anemia affected 45% of women and 26% of men, while vitamin D deficiency impacted 77% of women and 82% of men. Vitamin B12 deficiency was also significant, with 38% of men and 27% of women showing low levels.

was even more pronounced: 49% of

men and 35% of women were vitamin B12 deficient.

These gaps, if left unaddressed, can impair energy, cognition, and metabolic function. Apollo recommends widespread education as an essential function. first step towards improving national

# nutrition and long-term health. OBESITY AND METABOLIC DYSFUNCTION: THE CASCADE CONTINUES

The report highlights that 61% of individuals screened were obese, with another 18% overweight. Obesity continues to act as the root cause of a range of non-communicable diseases.

The report stated that Apollo supports expanding physical literacy in schools and workplaces and making BMI (body mass index) and metabolic screenings part of every annual health check.

Doctors even advocated for healthcare to move from a symptom-driven model to a preventive, data-led system.

They recommended making regular health check-ups part of school curriculums, corporate well programs, and insurance coverage. wellness

"This report shows that waiting for symptoms could be too late. Early screening, lifestyle changes, and awareness are the only way forward," said Dr Prathap Reddy.

when the health of mothers and children is ensured, the future generation of the country will also be healthy.

Dr. Jain added that government health institutions in the district are providing high-quality services for maternal and child health, including free tests, medicines, ultrasounds, meals, and transport facilities for patients traveling to and from health centers. Furthermore, newborns are provided free treatment for up to one year.

She appealed to pregnant women to prioritize their health and the health of

their babies by maintaining a balanced and nutritious diet and regularly undergoing necessary tests. During pregnancy, four essential check-ups, including weight, blood, urine, and blood sugar tests, are necessary. Dr. Jain also recommended including fresh vegetables, fruits, and milk in the diet.

Pregnant women were encouraged to visit government health institutions for routine check-ups. For any health-related information, individuals can contact the health department's helpline at 104.

# Roadside Potholes Cause Accidents, Municipal Corporation Officials Show Little Concern

Mohali: Persistent potholes on several key roads in Mohali have become a major safety hazard, leading to multiple accidents in recent weeks. Despite numerous complaints from the public and local authorities, officials from the Municipal Corporation (MC) have shown little urgency in addressing the issue, leaving commuters at risk.

Motorists and pedestrians have expressed growing frustration over the dangerous potholes, which are particularly prevalent in high-traffic areas. Several accidents, including some involving two-wheelers, have been reported due to the large, unfilled potholes. Many victims of these accidents have raised concerns about the lack of timely action from the MC in repairing the damaged roads.

Residents allege that despite repeated complaints to the concerned departments, there has been little or no response. "These potholes have been here for weeks, and nothing has been done about them. It is only a matter

of time before someone gets seriously injured," said a commuter who just had a narrow escape.

Commuters stated that accidents caused by potholes are becoming an increasing issue, leading to delays and posing risks to both road users and emergency responders.

Municipal Corporation officials,

Municipal Corporation officials, however, have been accused of being indifferent to the growing problem. While officials have acknowledged the issue, many claim that budget constraints and the need for a more thorough assessment of the roads are delaying repairs.

As the situation worsens, residents and commuters are calling on the authorities to take immediate action to fill the potholes and ensure road safety. Many are questioning whether public safety will ever be prioritized over bureaucratic delays, urging the Municipal Corporation to act before more accidents occur.

Meanwhile, BJP leader and Delhi minister Manjinder Sirsa criticized the Punjab government, accusing them of misusing teachers by asking them to become AAP's

social media team. Sirsa expressed concerns over teachers being instructed to create social media accounts and broadcast political programs instead of focusing on education.

Education Minister Harjot Singh Bains, in his address, countered the BJP's claims, stating that there is nothing wrong with promoting the government's achievements if they lead to improving education. He further added that the government's primary focus is on raising educational standards and addressing drug addiction issues through initiatives such as PTM (Parents-Teachers Meetings) in government schools.

The government claims that under the AAP's leadership, significant strides have been made to improve educational facilities, including Wi-Fi connectivity in over 17,000 schools. The government asserts that no student now sits on the floor, with 12,500 schools offering modern facilities.

CM Mann ended his speech with a call for unity, promising that Punjab's education system would continue to rise as they focus on fighting against drug abuse and pushing for quality education.

# HPSEBL to Be Strengthened, Assures CM Sukhu

Shimla: Chief Minister Thakur Sukhvinder Singh Sukhu, during a review meeting with the Energy Department, reaffirmed the state government's commitment to strengthening the Himachal Pradesh State Electricity Board Limited (HPSEBL) and enhancing its services for the people of the state.

The Chief Minister emphasized the importance of large-scale recruitment for field staff to ensure smooth ground-level operations. He praised the dedicated role of HPSEBL officers and employees in ensuring consistent electricity supply across the state.

In a significant move, CM Sukhu directed that several HPSEBL officers currently on deputation to the Directorate of Energy, Himachal Pradesh Power Transmission Corporation Limited, and Power Corporation be permanently absorbed into their respective organizations by April 30. The state government also plans to fill remaining vacant

posts on priority to improve the functioning of HPSEBL.

CM Sukhu also highlighted the upcoming formal inauguration of the 100 MW Uhl Phase-III hydroelectric project. The project, which had been delayed due to a penstock burst in May 2020, was fast-tracked by the current state government with a financial provision of Rs. 185 crore. Since its commissioning, the project has already generated 2.97 crore units of electricity. Initially started in 2003, the project has now been completed after 22 years, and once fully operational, it is expected to produce 392 million units annually, generating about Rs. 200 crore in revenue for the state each year.

The meeting was attended by Technical Education Minister Rajesh Dharmani, Chief Minister's Principal Advisor Ram Subhag Singh, Chief Minister's Secretary Rakesh Kanwar, Director Energy Rakesh Kumar Prajapati, Managing Director HPSEBL Sandeep Kumar, and other senior department officials.

# Farmers' Protest to Continue Until Demands Are Met, Dallewal Confirms

Chandigarh: Farmer leader Jagjit Singh Dallewal today reaffirmed that the farmers' agitation will persist until the government accepts their demands, including a legal guarantee for minimum support price (MSP) for crops.

Dallewal announced that farmer leaders would participate in the upcoming talks with the Centre scheduled for May 4. He emphasized that their presence was necessary to prevent the government from claiming that the farmers did not attend the meeting. "We will attend the meeting and strongly present our demands," he stated.

The farmer leader, who recently ended his 130-day hunger strike, clarified that the agitation was far from over. The Samyukta Kisan Morcha (Non-



Political) and Kisan Mazdoor Morcha (KMM), both of which Dallewal represents, will decide the next course of action in a meeting. These groups had led a year-long protest at the Shambhu and Khanauri border points in Punjab and Haryana, demanding a solution to their issues. The protest was cleared by police on March 19. Dallewal explained that 'Kisan

Mahapanchayats' would continue to be held across Punjab as part of the ongoing agitation. He also mentioned that similar events would be organized in Haryana and Rajasthan.

Responding to the upcoming meeting with the government, Dallewal confirmed that farmers' representatives

would attend, emphasizing their commitment to pushing for a legal guarantee on MSP.

Dallewal had called off his fastunto-death following requests from supporters. He was discharged from a private hospital in Khanna today after a check-up. The ongoing farmers' protest is set to intensify until their demands are met.

# Peer Mohammad Resigns from Akali Dal Over Unfulfilled 2 December Order

# Former Pb SSP, SP Sentenced to 5 Years in 2007 Sex Scandal

Mohali: A CBI court today sentenced former Moga SSP Devinder Singh Garcha and SP (Headquarters) Paramdip Singh Sandhu to five years of rigorous imprisonment, along with a fine of Rs 2 lakh each, in connection with the 2007 Moga sex scandal case.

Inspector Amarjit Singh received a sentence of six-and-a-half years of rigorous imprisonment and a fine of Rs 2.5 lakh, while Sub-Inspector Raman Kumar was sentenced to eight years of rigorous imprisonment and fined Rs 3 lakh. Both were convicted under the Prevention of Corruption Act (PCA). Additionally, Raman Kumar was convicted for extortion, while Amarjit Singh faced charges of attempting extortion.

charges of attempting extortion.
The scandal, which made national



headlines, involved high-ranking police officials and politicians allegedly extorting wealthy youths by trapping them in a sex trade case. The accused police officers had taken bribes to manipulate the statements of two women, dropping the names of the accused.

accused. While Barjinder Singh (alias Makhan), son of former SAD minister, and Sukhraj Singh were acquitted on March 29, the case continues to have lasting repercussions. It was discovered in 2007 after the highprofile involvement of politicians and senior police officials.

In the case's aftermath, the high court ordered a CBI investigation, acknowledging the difficulty of proceeding due to the powerful figures involved. In 2012, charges were framed against the accused

under multiple sections of the IPC and the Prevention of Corruption Act. The scandal's investigation was further complicated by a key witness, Manjit Kaur, who died during the trial, and another minor girl who initially turned approver but later became hostile.

# Gangster Happy Passia Claims Rocket Attack on Police Station; Cops Deny

# Karma Review: A Gripping, Gritty Tale of Fate and Retribution

New Delhi: If you think you can outrun your karma, think again. 'Karma', the latest South Korean crime thriller from director Lee Ilhyung, lands on Netflix with a six-episode punch that's tight, bold, and relentlessly intense. The show is based on Choi Hee-seon's Kakao webtoon that takes the concept of fate and twists it into a volatile thriller where no one walks away clean.

At its core, Karma is about six people—each harbouring secrets, guilt, and hunger for something just out of reach. Their stories spiral around one another like a slowburning fuse, and when it finally hits the powder keg, the fallout is messy, violent, and deeply human. The show doesn't waste time; every episode peels back another layer, exposing how past sins bleed into present choices. There's no redemption arc here without cost.

Lee II-hyung's screenplay is sharp and meticulous. In just six episodes, he manages to thread a complex narrative without ever feeling rushed or overloaded. The pacing is surgical. You think you know where it's going? Think again. Every time the show sets up an expectation, it flips it. You guess "A," it hits you with "B," and not for shock value—each twist lands



Performance-wise, the cast delivers across the board, but Lee Kwang-soo, Park Hae-soo, and Shin Min-a are standouts. Typically known for his comedic roles, Kwang-soo [Running Man], surprises with a dark, layered performance that stays. Hae-soo [Squid Game] brings intensity with a chilling undercurrent. On the other hand, Min-a [Hometown Cha Cha Cha] is quietly devastating—a mix of grace and suppressed rage. Kim Nam-Gil in an extended role is quite impressive as well. The way they hold the emotional weight of the show while pushing the plot forward with raw, believable energy is interesting till the end.

The action is well-choreographed. It's not stylised for the sake of it; every punch and blood splatter has

narrative weight. And yes, there's gore—but not just for shock. This is Korean storytelling after all: unafraid to go dark when the story demands it, and Karma demands it often.

The cinematography keeps tension high with moody framing. The shadow-drenched alleys and stark interiors make you feel trapped in the same fated spiral as the characters. There's a lingering dread to every scene, as if karma itself is watching—and waiting, which makes it a thrilling watch.

In the end, Karma doesn't just tell you that fate catches up. It shows youbrutally, elegantly, and with no easy way out. With standout performances and razor-sharp storytelling, it's one of the most compelling Korean dramas of the year. Watch it-just don't expect to sleep easy after.

Kashyap was first diagnosed with breast cancer in 2018. Known for her directorial debut, 'Sharmaji Ki Beti',



she has been a regular advocate of being aware of the disease. She has also been leading body positivity campaigns, by sharing her own surgery scars. Kashyap also embraced baldness and refused to wear a wig to hide it during her first chemotherapy

In an interview with Filmfare earlier this year, she talked about undergoing a mastectomy, and shared that her parents didn't talk to her after she posted her photos of a bald look on

social media. She said, "My parents got really upset with me when I put up my bald picture (after the cancer diagnosis). A bald look for a woman is somehow synonymous with disaster, so they refused to talk to me and were forcing me to take it down

Kashyap remembered telling her parents that she wanted to 'celebrate' that phase of her life, while they couldn't understand what 'celebrating

# SC Rejects Urgent Hearing on Waqf Act, Chief Justice **Affirms System in Place**

Kolkata: The Supreme Court today declined an urgent hearing on pleas challenging the Waqf (Amendment) Act, 2025, saying that "there's a system in place" to handle such matters. The petition challenges the constitutional

validity of the newly notified Waqf (Amendment) Act, 2025, and seeks directions to the Centre to defer bringing the law into force.

Senior Advocate Kapil Sibal mentioned the plea filed by Jamiat Ulema-i-Hind President Maulana Arshad Madani before a bench led by Chief Justice of India (CJI) Sanjiv Khanna.

Sibal urged the bench to consider listing the matter urgently, highlighting concerns raised by multiple petitions. However, the CJI reiterated that all urgent matters would be placed before him in the afternoon and that the court would "take a call on listing" them accordingly.

Questioning the need for repeated oral



mentions, the CJI said, "Why are you mentioning when we have a system in place?" He assured that the matters would be reviewed in the afternoon and the "needful will be done."

Multiple petitions arising out of the Waqf Act amendment have been mentioned before the apex court since the Centre's notification of the legislation.

President Droupadi Murmu on Saturday gave her assent to the Waqf (Amendment) Bill, 2025, which was earlier passed by

Parliament after heated debates in both Houses. Several petitions, including one by Samastha Kerala Jamiathul Ulema, have been filed in the apex court challenging the validity of the Act.

In its petition, the Jamiat Ulama-i-Hind has said that this law was a "direct attack on the country's Constitution, which not only provides equal rights to its citizens but also grants them complete

# Minister Faces Backlash for Remark on Woman's Street Molestation

I have also instructed our commissioner to increase beat patrolling," G Parameshwara said. Last week, CCTV footage went viral on social media showing a man groping a woman on a street at Bharati Layout in Suddaguntepalya before fleeing. The



incident happened in the early hours of

The video shows a man approaching two women walking in a narrow lane before pushing one of them against a wall. The man then gropes her and touches her inappropriately before running away. The two women, visibly startled by the incident, walk away from the area, the

footage shows.

Bengaluru police have registered a suo motu case after the incident sparked outrage even though the victim is yet to file a complaint.

The case has been registered under Section 354B (assault or use of criminal force with intent to disrobe

Last year, a similar incident was caught on camera in August. A woman in Bengaluru's Konanakunte

area was groped by a man during her morning walk. The accused, who was a cab driver, was arrested two days after the incident took place.

According to government data shared last year, Bengaluru saw a significant increase in crime against women in 2023, with police registering 3,260 cases, including 1,135 related to molestation.

# Kunal Kamra Moves HC Challenging FIR in Parody Controversy

Mumbai : Stand-up comedian Kunal Kamra has approached the Bombay High Court, seeking the cancellation of cases registered against him for jokes targeting Shiv Sena leader and Maharashtra Deputy Chief Minister Eknath Shinde. The petition argues that the cases infringe upon his fundamental right to the freedom of expression under Article 19 and the right to life under Article 21 of the Constitution. The matter is scheduled to be heard on April 21, but the comic may press for an

urgent hearing.

The Madras High Court earlier granted the comic interim protection from arrest till today. He has skipped three summons from Mumbai Police. Kamra hit headlines last month after

his remarks at a show shot at Mumbai's Habitat Studio went viral on social media. The comic sang a parody of 'Bholi Si Surat', a popular song from the Bollywood movie 'Dil To Pagal Hai'. The lyrics targeted Mr Shinde, referring



to him as 'gaddar' (traitor). Mr Shinde led the rebellion that split the Shiv Sena and toppled the Uddhav Thackeray government in 2022. Mr Thackeray has often used the 'gaddar' insult against his former lieutenant.

Infuriated by Kamra's remarks, Mr Shinde's supporters vandalised the Habitat studio, a preferred venue for stand-up comedy shows. The studio in Khar subsequently shut down, stressing that it exercises no control over the content of any show. Parts of the studio were demolished the next day, with civic authorities citing building law violations. But the timing of the action has sparked a buzz that the action was linked to the Kunal Kamra controversy.

Kunal Kamra has stressed his right to freedom of speech and said, "Your inability to take a joke at the expense of a powerful public figure does not change the nature of my right. As far as I know, it is not against the law to poke fun at our leaders and the circus that is our

# Sensex Plunges 3,000 Points. Nifty Dips as Trump Tariffs Shake Global Markets

New Delhi: Benchmark stock market indices plunged sharply today, imitating the global market as uncertainty over Donald Trump's tariffs fuelled the bloodbath. The S&P BSE Sensex crashed 2564.74 points to 72,799.95, while the NSE Nifty50 tanked 831.95 points to 22,072.50 as of 9:24 am.

With today's stock market crash, the Sensex and Nifty have plunged to their lowest levels in approximately 10 months.

lowest levels in approximately 10 months, and analysts suggest that they could fall further due to massive volatility in global markets. The crash was so severe that it wiped out Rs 19 lah crore from the combined market capitalisation of BSElisted firms

Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said that globally markets are going through heightened volatility caused by extreme uncertainty. "No one has a clue about how this turbulence caused by Trump tariffs will evolve. Wait and watch would be the best strategy in this turbulent phase of the market," he added.

All 13 major sectoral indices were trading in the red. Broader market indices also suffered steep losses. The small-cap index dropped 10%, and mid-caps declined by 7.3%.



In Monday's trading session, the domestic stock market witnessed carnage; there was not a single gainer in sight across the BSE Sensex. The market crash was particularly severe for Tata Steel, which plummeted 11.25%, marking the steepest decline among all stocks. Tata Motors followed with a sharp drop of 8.24%, while Tech Mahindra tumbled 6.70%. Infosys and HCLTech rounded out the top five losers, both sliding 6.00%.

The market sell-off was widespread and relentless, with even traditionally defensive sectors offering no refuge for investors. Heavy selling pressure was evident across all segments, with banking, technology, and automobile stocks bearing the brunt of the negative sentiment.

The comprehensive red screen signals significant investor anxiety,

potentially triggered by broader specific sectoral headwinds

Domestic consumption themes like financials, aviation, hotels, select autos, cement, defence and digital platform companies are likely to come out relatively unscathed from the ongoing crisis. Trump is unlikely to impose tariffs on pharmaceuticals since he is on the back foot now and, therefore, this segment is likely to show resilience," said Vijayakumar. GLOBAL MARKETS BLEED

The slump on Dalal Street mirrored the heavy losses seen on Wall Street and across key Asian markets, with the MSCI Asia ex-Japan index falling 6.8%. Japan's Nikkei 225 tumbling 6.5%.

The sharp global market sell-off came after US Federal Reserve Chair Jerome Powell said on Friday that newly announced tariffs by former President Donald Trump were "larger than expected" and significantly affect inflation and economic growth, casting doubt over the US outlook.

The Nasdaq officially entered bear market territory as commodity prices, including oil, fell sharply in response to Trump's sweeping tariff announcement made earlier in the week.

# **BJP MLA Claims Waqf Law Will Curb** 'Land Jihad', Calls for 'Hindu Rashtra'

Hyderabad: BJP's Telangana MLA T Raja Singh said the amended Waqf law

would put an end to what he described as "land jihad" in the country.

Speaking during a Ram Navami procession in Hyderabad, Singh claimed that since the formation of a "saffron" government," those issuing Waqf notices

over land had started facing pushback.
"Those who used to put up a board (on a land parcel) in the name of 'land jihad' by issuing a Waqf notice, as if it was the property of their father, will no longer be

able to do so," Singh said. He attributed the change to the Waqf (Amendment) Bill, 2025, which recently became law after President Droupadi

Murmu gave her assent. The legislation, passed last week in Parliament amid heated debate, amends key provisions related to the functioning and powers of Waqf Boards in India. Critics, including AIMIM president and Hyderabad MP Asaduddin Owaisi, have argued that the changes weaken protections for Waqf properties and endowments belonging to various religious communities.

Singh questioned the current scale of Waqf holdings. "At the time of Independence, Waqf board people had 4,000 acres. How did they end up with 9.5 lakh acres?" he

asked. He also attempted to reassure Muslim citizens, claiming that the new law would

not take away their lands.
"Muslims should understand that this isn't about snatching property. It's about



justice," he said, invoking Prime Minister Modi's slogan "Sabka Saath,

Taking aim at Owaisi, Singh called him the "biggest enemy of Muslims" and said his petition in the Supreme Court challenging the amended law would have no effect.

In his plea, Owaisi has argued that the new law strips Waqf properties, as well as Hindu, Jain, and Sikh endowments, of key protections.

TRaja Singh went further during the rally, declaring that it was the "demand of every Hindu" that India be declared a "Hindu

# India Chooses Restraint: Rejects Counter-Tariffs on **US Amid Market Turmoil**

New Delhi: India is unlikely to impose counter-tariffs on the US and focus on finalising the bilateral trade agreement as quickly as possible after the Donald Trump administration slapped a 26% duty on exports from the country, a government official told. Trump's move has shaken global markets as well as Dalal Street, with the Sensex losing 1.6% since.

The government is banking on a key clause in the executive order signed by Trump last week that offers respite to nations who take "significant steps to remedy non-reciprocal trade arrangements", the official said.

Another government official pointed out that India was taking comfort in the fact that it was one of the first nations to have started talks on a trade deal with the US. Its Asian peers, like China (34%), Vietnam (46%), and Indonesia (32%), have been

hit by higher tariffs. While China said it would impose reciprocal 34% tariffs on all imports from



the US from April 10, Indonesia said it would not retaliate. Vietnam, an emerging manufacturing and export alternative to China, has agreed to slash its tariffs to zero in a potential trade deal.

Last week, Trump announced a 26% reciprocal tariff on India even though he called Prime Minister Narendra Modi a 'great friend".

The silver-lining for India is that semiconductors, copper and pharmaceuticals are exempt from the US tariffs. India supplies nearly half of all generic medicines in the US. However,

exports in key sectors like electronics, auto parts, gems and

jewellery may take a hit. While India has been cautious in its response to the tariffs, the opposition has attacked the government for failing to get a reprieve despite the "camaraderie" between PM Modi and Trump.

Leader of the Opposition in the Lok Sabha Rahul Gandhi has said the tariffs would "completely

devastate" the economy.

The proposed Bilateral Trade Agreement (BTA) with the US has seen considerable progress. Last month, the two nations agreed to the terms of reference for the

# Are Trump's Tariffs Effective? Vietnam and Taiwan Offer Zero Duty on US Imports

New Delhi : Are Donald Trump's sweeping tariffs on the US's allies and adversaries working? Five days after the announcement sent global markets into a tailspin, nearly 50 countries have dialled the White House while a few others have decided to do away with tariffs on US imports altogether.

Vietnam and Taiwan, among the countries to face the steepest US reciprocal tariffs, have offered to eliminate all levies as the basis for trade talks. Other nations like India and Indonesia have also decided not to retaliate after Trump left the door open on one-to-one deals if countries addressed their trade deficits with the US.

#### VIETNAM OFFERS ZERO TARIFFS ON US PRODUCTS

Vietnam was the first off the block to slash its tariffs on US imports to zero after the US imposed a hefty 46% duty on goods from the Southeast Asian nation. The development came after Vietnamese leader To Lam spoke with Trump in the weekend in what the US President called a "very productive" call.

"Just had a very productive call with To Lam, general secretary of the Communist Party of Vietnam, who told me that Vietnam wants to cut their tariffs down to ZERO if they are able to make an agreement with the US," Trump posted on Truth Social.

Vietnam has already cut several duties in the lead up to Trump's reciprocal tariff announcement, dubbed Liberation Day, and has also pledged to buy more American planes and agricultural

The US is Vietnam's biggest export market and the 46% import duty threatens to upend its economy, which is heavily reliant on trade.

Amid tensions between China and the US, Vietnam has rapidly emerged as a manufacturing hub in recent years. As companies diversified their supply chains, it gave Vietnam's economy a leg-up.

#### TAIWAN TO REMOVE TRADE **BARRIERS**

Another Asian country that has offered zero tariffs on US products is Taiwan. On Sunday, Taiwan President Lai Ching-te pledged to remove trade barriers after it was slapped with a steep 32% US tariff. The move, which Taiwan's President has

called "unreasonable", comes despite the Asian country's announcement of a \$100-billion investment in US chip factories. Taiwan, which runs a large trade surplus with the US, has also made major commitments to invest in US energy

In March, Taiwan's semiconductor giant TSMC announced that it would expand its investment in advanced semiconductor manufacturing in the US, pledging an additional \$100 billion. TSMC's major customers include Apple, NVIDIA, and Qualcomm. Semiconductors are, however, exempted from US tariffs.

#### INDIA, INDONESIA UNLIKELY TO RETALIATE

Even though several countries have pushed back against Trump's tariffs, with some, like China, imposing swift countermeasures, nations like India and Indonesia have decided to rely on diplomacy and negotiations.

Indonesia's chief economic minister

Airlangga Hartarto told Reuters the country won't retaliate against Trump's 32% tariff and instead find "mutually beneficial solutions".

India, which has been hit with a 26% tariff, has decided to focus on finalising the bilateral trade agreement with the US as quickly as possible, a government official told.

The official said the Narendra Modi-led government was banking on a key clause in Trump's executive order that offers respite to nations who take "significant steps to remedy non-reciprocal trade arrangements".

# Hajj 2025: Saudi Arabia Temporarily Bans Visas for India and 13 Other Countries

New Delhi: With the Hajj pilgrimage around the corner, Saudi Arabia has temporarily suspended the issuance of certain visas to citizens of 14 countries, including India, Pakistan, and Bangladesh. The ban on Umrah, business and family visit visas will be effective till around

mid-June, coinciding with the conclusion of the pilgrimage to Makkah.

The ban impacts 14 nations, including India, Pakistan, Bangladesh, Egypt, Indonesia, Iraq, Nigeria, Jordan, Algeria, Sudan, Ethiopia, Tunisia, Yemen, and Morocco.

The step was reportedly taken to prevent individuals from trying to perform Hajj without proper registration. However, individuals holding Umrah visas can still enter Saudi Arabia until April 13, quoting Saudi authorities.

The reports said the ban was necessitated as many foreign nationals have entered the country on Umrah or visit visas in the past



and then overstayed illegally to participate in the Hajj without official authorization, leading to overcrowding and intense heat. In one such incident during the Hajj in 2024, at least 1,200 pilgrims were killed. The kingdom has a quota system, which allocates specific Hajj slots to each country to regulate the number of pilgrims. People participating illegally in the Hajj bypass this system. Another reason move was illegal employment. Authorities said that foreigners, using business or family visas, engaged in unauthorized work in Saudi Arabia, violating visa rules and causing labor market disruptions.

The Saudi Ministry of Hajj and Umrah has assured that the move has nothing to do with diplomatic concerns and was only taken as a logistical response to ensure a safer and better-organized pilgrimage.

Reports said that authorities have asked the affected travelers to comply with the new rules, as individuals found violating the order may face a five-year restriction on future entries.

Meanwhile, diplomatic visas, residency permits, and visas particular to the Haji remain unaffected by the move. The Haji 2025 season is set for June 4-9.

# Global Markets Plunge as Trump's Tariff Tsunami Erases Trillions

New Delhi: Markets across the globe plunged into chaos today as Donald Trump's sweeping tariffs sent shockwaves from Wall Street to Asia. With no signs of backing down, US President Donald Trump doubled down on his aggressive trade stance, demanding that other nations "pay a lot of money" to lift duties as high

Asian markets have been hit particularly hard, with markets in Japan and Taiwan hitting circuit breakers for the first time since March 2020. In Tokyo, the Nikkei 225 nosedived to its lowest level in over 18 months, with banks shedding almost a quarter of their market cap in just three sessions. India's Dalal Street fared no better, with the Sensex and Nifty crashing

more than 5% in pre-open trade. At around 9:32 am, the Sensex was down 2,497.08 points to 72,867.61, and the Nifty50 fell 807.70 points to trade at 22,096.75. Broader indices, especially small- and mid-caps, bled heavily as the ripple effects of a potential global

recession gripped investors.

It may be noted that the global stock market crash has already wiped off trillions of dollars in market capitalisation, hitting shares of some of the biggest companies in the world. # Mamata Banerjee Vows to Support Sacked Bengal Teachers, Defies Threat of Jail

Kolkata: West Bengal Chief Minister Mamata Banerjee met with a section of sacked teachers at Kolkata's Netaji Indoor Stadium today and vowed to back them and assured that eligible candidates would not be jobless. The development comes days after the Supreme Court upheld the cancellation of 25,752 school job appointments made through the 2016 West Bengal School Service Commission (WBSSC) recruitment.

"Please don't consider that we have accepted it. We are not stone-hearted, and I can even be jailed for saying this, but I don't care," says West Bengal CM Mamata, addressing people who lost their jobs as teaching and non-teaching staffers in West Bengal government-run and aided schools after a Supreme Court

order.

She added, "We have separate plans to ensure eligible candidates don't become jobless or have break in service. My name being dragged into something about which I have no inkling."

The top court's April 3 verdict cited large-scale irregularities and fraud in the recruitment process, leading to the dismissal of thousands of teachers. While Mamata Banerjee has vowed to abide by the court's ruling, she called the verdict unjust for deserving candidates.
"We are victims of a system we had
no hand in manipulating," said Yasmin
Parveen, one of the dismissed teachers, outside the venue. "We need nothing but our jobs back."

On stage with the Chief Minister were 20 teachers—part of a group created by Mamata herself—along with West Bengal Education Minister Bratya Basu. The move has sparked criticism from

# the Opposition. **BENGAL BJP PROTESTS**

At the same time as Mamata was meeting the dismissed teachers, the Bengal BJP called for a protest march to the Chief Minister's Kalighat residence over the same issue. The march is scheduled for 1 pm.

BJP leader Suvendu Adhikari accused Mamata Banerjee of favouring only a select few. "She is not the Chief Minister but TMC's leader. If she was Chief Minister, then she would have met all the teachers, not only some," he said. Suvendu Adhikari is sitting in protest with BJP MLA's inside state assembly with "Mamata Chor" posters even as Mamata Banerjee meets teachers who

The controversy began with the 2016 SSC recruitment drive, which received 23 lakh applications for 24,640 vacancies. However, more appointment letters were issued than available posts. # ED Raids Properties Linked to Stalin Minister KN Nehru and Son in Bank Fraud Probe

New Delhi : The Enforcement Directorate conducted searches at multiple locations connected with Tamil Nadu Minister for Municipal Administration, Urban and Water Supply KN Nehru and his son, Lok Sabha member Arun Nehru.

According to sources, the raids were reportedly in connection with a Rs 22 crore bank fraud case, which was registered based on a complaint by Indian Overseas Bank against Truedom EPC Limited. Minister Nehru's brother N Ravichandran is a director with Truedom EPC Limited. There were also reports that raids were conducted at locations linked with real estate firm True



Value Homes (TVH), owned by N Ravichandran. The ED conducted raids at 13 locations in Tamil Nadu, including the Minister Nehru's house in Trichy.

The ED raids come on the heels of similar raids in Chennai against AM Gopalan's chit fund company

Sree Gokulam Chits. AM Gopalan, also known as Gokulam Gopalan, is one of the producers of Empuraan, a Malayalam film that created a stir at its release because of how it showed the Gujarat riots and the part played by right-wing Hindu groups. Similarly, Empuraan's director and actor

Prithviraj Sukumaran received from the Income-Tax a notice department to explain his earnings from three films that came out in 2022: Jana Gana Mana, Gold and Kaduva. He was given time until April 29 to respond to the notice.

# **New CPM General Secretary Defends** CM's Daughter, Calls Case 'Fabricated'

New Delhi: Newly elected CPI(M) General Secretary MA Baby strongly defended Kerala Chief Minister Pinarayi Vijayan's daughter, T Veena, after she was named by the Serious Fraud Investigation Office (SFIO) in an alleged illegal navment case.

Baby claimed the case against Veena was "fabricated" solely because she is the daughter of Pinarayi, who he described as the "head" of the CPI(M) and the ruling Left Democratic Front (LDF) in Kerala. "To attack the CPI(M) and the LDF in

Kerala, they have to hit at its head...and its head is Pinarayi Vijayan," he said in an interview with a Malayalam news channel on Monday, a day after being elected to

the party's top post. This is Baby's first major political statement as General Secretary, and it comes amid mounting pressure on Vijayan from the Congress and BJP, who are demanding his resignation following reports that the Ministry of Corporate Affairs has approved prosecution against Veena. Media reports allege that Veena received Rs 2.70 crore from a private mining company without providing any services through her IT firm.

Baby questioned the basis of the case, asking what illegal benefits the company received from the Kerala government in return. He also accused central agencies of being politically motivated. "Everyone knows how the central agencies are functioning," he said, calling the investigation "the worst form of an anti-

democratic approach."
He also criticised a tribunal under the Union Finance Ministry for allegedly singling Veena out by noting her relationship with a prominent political leader, which he said sparked the entire

### FROM POLITBURO TO TOP POST

MA Baby, a CPI(M) Politburo member since 2012, was elected General Secretary at the party's 24th All India Congress, which concluded on Sunday. He is the second leader from Kerala to hold the post, after EMS Namboodiripad. While former General Secretary Prakash Karat is also from Kerala, he was part of the party's Delhi unit.

Baby's election came after some leaders backed All India Kisan Sabha president Ashok Dhawale for the top post. CPI(M) leaders Surya Kanta Mishra, Nilotpal Basu, Mohd Salim, and Ramchandra Dome reportedly supported Dhawale. However, the party eventually rallied behind Baby, who called him "obedient soldier" of the CPI(M). who called himself an

The post fell vacant after the death of Sitaram Yechury last September. Prakash Karat served as interim coordinator in the run-up to the party congress

In his message to party delegates after being elected, Baby acknowledged the party's decline and urged every member to work together to revive its strength. He emphasised activating mass organisations, which together have over five million members, to face future challenges

# Drunk TV Director's Car Rams Crowd, 1 Dead, 6 Injured

Kolkata: One person died, and six others were critical after a private car rammed a crowd in one of the busiest marketplaces in South Kolkata on a

last morning.
A director of a daily soap and an executive producer from a renowned Bengali entertainment channel were in the car at the time of the accident, according to the police.

Following the incident, both were stopped by locals and beaten by the agitated crowd before being handed over to the police. As officers rushed to the spot to rescue them, an official told that the co-passenger, Shriya Basu, appeared to be intoxicated and collapsed on the road.

At the time of the crash, Siddhanta Das alias Vikto - a renowned director in Bengali film industry - was behind the wheels and was subsequently arrested by the Kolkata Police.

Shriya Basu, an executive producer, was handed over to her family after



being rescued by the police from the

Sources confirmed that both were under the influence of alcohol.

According to a source who spoke to India Today, the two were out partying till late night before the incident. They were at a pub in Kolkata's South City Mall, celebrating the success of their show. While the rest of their group dispersed at around 2 am, the two continued drinking, driving round the city for the remainder of the night. On LAst morning, their car entered

Thakurpukur Bazar and began hitting pedestrians. "The vehicle was coming from the Bishnupur side. After the

crash, we found only one person inside the car," an eyewitness told.

A Kolkata Police official said, "At around 09:30 hrs near Thakurpukur Bazar on Diamond Harbour Road under the Thakurpukur Police Station, a private car hit several pedestrians. As a result, six people sustained

multiple injuries. Four were taken to Kasturi Nursing Home, and two were shifted to CMRI Hospital in critical condition. The police seized the offending vehicle and detained the driver. An investigation

is underway."
The injured are currently undergoing treatment at a hospital. One of the victims, Aminur Rahman, a sweeper with the Kolkata Municipal Corporation and a local CPI(M) leader, died in the accident.

The accused, Siddhanta Das, is expected to be produced in court

### 19-Year-Old Woman Stabbed Multiple Times on Busy Road

New Delhi: A 19-year-old woman was knifed several times by a man in full public view in the Kirbi Place bus stop area of southwest Delhi, a police officer said today. The man, 20, later injured himself

with the same knife, he said. The matter was reported to police around 9.30 pm by a passerby. "The girl sustained serious

injuries to her neck and the left side of the abdomen. A knife was recovered from the scene. Both were hospitalised and are under treatment," the officer said.

On inquiry, it was revealed that the



accused, Amit, and the victim girl had been friends since last year and had had a fallout over some issue.

"Both were admitted to DDU

Hospital and are under treatment. A case under section 109(1) of the BNS has been registered against accused Amit at Delhi Cantt Police Station and investigation is under progress," said the officer. Meanwhile, a video, purportedly of the incident, made rounds on social media.

The 45-second clip shows the man and the woman sitting on the road divider in a bloodied state and a crowd of passersby gathered around them.
